

HEALTH & SAFETY PROCEDURES

St. Lawrence Cruise Lines has instituted a number of procedures designed to protect the health and safety of our passengers and crew. These procedures have been thoughtfully developed in accordance with federal, provincial, and regional guidelines. These procedures may change in the future according to the status of federal and provincial health requirements.

Passenger Screening	As of October 1, 2022 proof of COVID-19 vaccination is not required. All passengers must be willing to receive a Covid-19 antigen rapid test if requested by the safety officer on board. St. Lawrence Cruise Lines recommends that all travellers undergo a rapid test before leaving home for travel. All crew members will be assessed prior to boarding.
Passenger Monitoring (Cruising)	The well-being of all passengers and crew will be monitored throughout the cruise. Passengers are urged to alert our cruise director if they experience flu-like symptoms.
Air Purification System	St. Lawrence Cruise Lines employs high quality HEPA air purifiers in the Grand Saloon of the Canadian Empress, which serves as the observation room during the day, the dining room during meal times, and as the lounge during evening entertainment.
Transportation and Shore Tours	All shore tours and transportation to and from attractions have been vetted and approved by the Cruise Line in order to ensure that they meet health and safety guidelines. Passengers will be asked to abide by the health and safety restrictions practiced by individual attractions and coach services.
Masking	At the current date, masks are no longer required. However, this may change in the future based on federal and provincial guidelines.
Hand Sanitation Stations	Hand sanitation stations have been placed throughout the ship, including common areas.
Electrostatic Disinfectant Program	A surface disinfectant regime will be used for all high touch surfaces with cleaning products that have been federally recommended. Our hospital-grade electrostatic cleaning system has been endorsed by Health Canada and will be used for the daily sanitization of common interior areas.

CANADIAN TRAVEL GUIDELINES

For all travellers entering Canada by air, land or marine mode on or after October 1, 2022:

- Proof of COVID-19 vaccination is not required
- COVID-19 pre-entry and arrival tests are not required
- Quarantine after you enter Canada is not required
- Using ArriveCAN is not required
 - if you're flying into Toronto Pearson, Vancouver or Montréal-Trudeau international airports, you can still use ArriveCAN to complete your Advance CBSA Declaration to save time upon arrival
- As always, travel documents are required

Please note that Travel Requirements are constantly changing and evolving and you should always seek out the most up-to-date information at the Government of Canada's website.
